ONE: The name of the corporation is:  
VENTURA COUNTY  
ULTRALIGHT AIRCRAFT SOCIETY, INC.

TWO: This corporation is a nonprofit mutual benefit corporation organized under the Nonprofit Mutual Benefit Corporation Law. The purpose of this corporation is to engage in any lawful act or activity for which a corporation may be organized under such law. Such purposes for which this corporation is formed are pleasure, recreation, and other non-profitable purposes.

The specific purpose of this corporation is the instruction or training of individuals for the purpose of improving or developing their capabilities in the operation of ultralight aircraft.

Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

THREE: The name and address of the corporation's initial agent for service of process is: Henry S. Blatt, 801 North M Street, Oxnard, California 93030.

FOUR: The corporation may admit persons to membership subject to the terms and conditions set forth in the bylaws.

SEVEN: An existing unincorporated association known as Ventura County Ultralight Association is being incorporated by the filing of these articles.


